### **Bridge Financing Program\***

Practitioners can utilize a bridge financing program\* for up to six months, during which time, there will be an interest rate of 1% per month. Insurance proceeds can be used to pay off the agreement before the end of the sixth months. After six months, if the agreement is not paid off, it will convert into a five-year agreement with a fixed interest rate.
